## UNANIMOUS WRITTEN CONSENT OF THE BOARD OF DIRECTORS IN LIEU OF MEETING OF THE BOARD OF DIRECTORS - RESOLUTION

### [APPROVING INCREASE IN REGULAR ASSESSMENT]

Cross-reference to that certain Declaration of Condominium Regime for Sonterra I Condominiums, recorded under Document No. 2016002134, Official Public Records of Williamson County, Texas, as amended from time to time (the "Declaration").

## RESOLUTION TO APPROVE INCREASE IN REGULAR ASSESSMENT

The undersigned, being the Directors of Sonterra I Residential Condominium Community, Inc., a Texas non-profit corporation (the "Association"), do hereby consent, pursuant to Section 22.220 of the Texas Business Organizations Code and Section 82.108(c)(2) of the Texas Property Code and in lieu of the holding of a meeting of the Board of Directors, to the adoption of the following resolution:

WHEREAS, Section 6.4.1 of the Declaration provides that Regular Assessments "are used for Common Expenses related to the recurring, periodic, and anticipated responsibilities of the Association . . .";

WHEREAS, Section 6.4.2 of the Declaration provides that the Board "will prepare and approve an annual budget with the estimated expenses to be incurred by the Association for each fiscal year. The budget will take into account the estimated income and Common Expenses for the year, contributions to reserves, and a projection for uncollected receivables";

WHEREAS, Section 6.4.3 of the Declaration provides that Regular Assessments "will be based on the annual budget";

WHEREAS, the Board has established the 2024 annual budget for the Association and determined that an increase in Regular Assessments is necessary in order to meet the budgetary requirements for the Association.

NOW, THEREFORE, the Association hereby adopts the following resolution:

1. The amount of the Regular Assessment per Unit is hereby increased from \$312.00 to \$400.00 per year beginning with the Regular Assessment levied by the Association in 2024.
